Dear Friends,

2008 was a good year for Village children and families. For this, we have many of you to thank.

We opened our second home for latency aged children (6-12 years old). It's a home for severely troubled boys which we named for Beverley Sorenson, a major supporter. It follows the successes we have experienced with equally troubled girls in our Little Girls Home, which opened in 2005. The Sorenson Home is full with six youngsters who are making great strides in overcoming the awful burden of early and severe abuse and neglect. We thank the Sorenson Legacy Foundation for providing the majority of the funding for this home, and we are proud to name the home for Beverley, with whom we have had a long and fond relationship.



Over 230 families were served with Families First in 2008, including some who were participating in the Garret Lee study, a federally funded study by the University of Utah Department of Psychiatry, the Juvenile Courts and the Utah Department of Health. This study is designed to curtail teenage suicides in Utah, which are substantially above the national average. Families First was chosen because of its record of success in helping families change the behaviors of their troubled children.

In our Little Girls Home, six girls who have spent much of their young lives in psychiatric institutions, are being taught to succeed in a family setting. Four girls graduated in 2008. All of them went home, to long-term foster care or were adopted. This is a 100% success rate with some of the most intractably difficult girls in our state.

Our two Kearns Homes and our Raymond Home for boys continue to provide a unique service to Utah. The boys in these homes have specific behavioral problems that Utah Youth Village has successfully changed for many years.

Our Residential Treatment program in Tooele County, Alpine Academy, opened its sixth home during 2008. This home is an independent living home for girls 18 years and older who need extra support as they transition from school-based therapy into higher education or the job market.

In 2008, we began serving refugee children in our Treatment Foster Homes. These children are placed in special Utah Youth Village foster homes by Catholic Community Services, which collaborates with the United Nations High Commission for Refugees to get children from refugee camps in unstable Third World countries into homes in America.

At our 2008 Helping Hand Gala, Honorary Chair Ellis Ivory, Chairman of the Board for the Deseret News Publishing Company, helped us honor H. David Burton, Presiding Bishop of the Church of Jesus Christ of Latter-day Saints. Many of our community's most distinguished leaders joined us in honoring Bishop Burton for his exemplary life of service and excellence.

Thanks to Dillard's, we presented our 31st annual Fashion Show & Luncheon, a once-in-a-lifetime opportunity for 20 Village youth who joined professional models on the runway to model their new outfits, purchased by generous sponsors. For some, these outfits were perhaps the only new clothing they have ever owned.

We want to thank departing board members Pamla Lanningham, Tom and Jan Murdock, and Merilyn Harvey for their many years of devoted service. We welcome new board member, Julianne Grant, Communications & PR Director for L-3 Communications, Communication Systems-West, and look forward to the many contributions her enthusiasm and commitment will provide for Utah children.

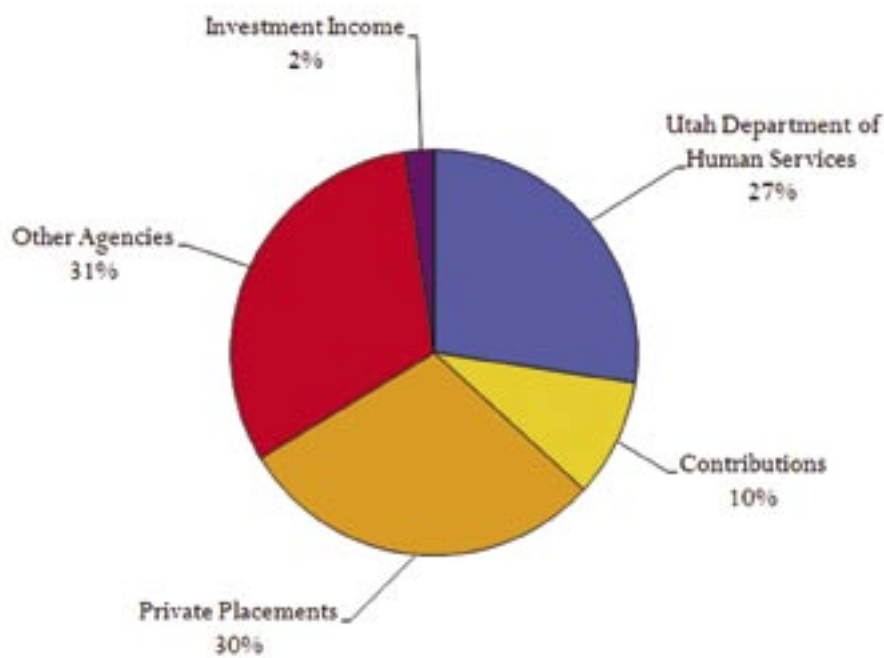

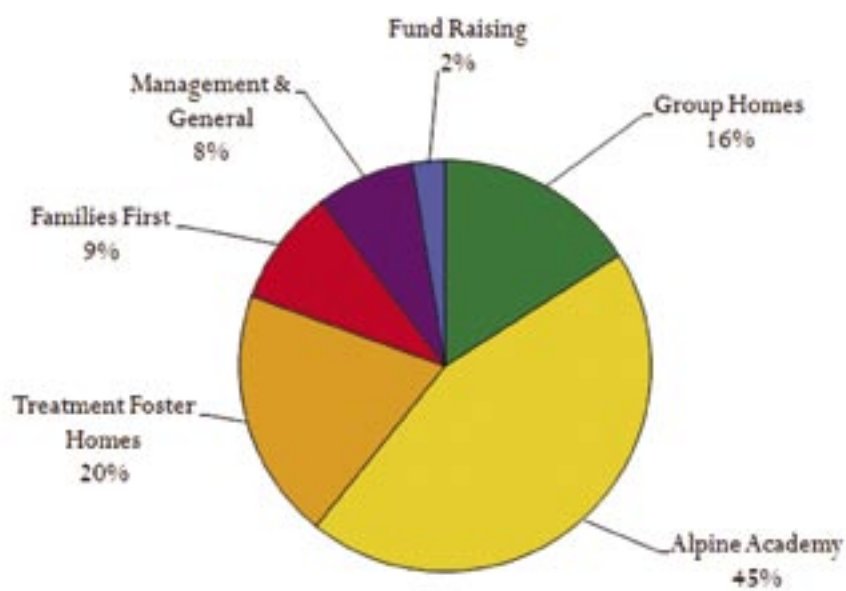
